AAUW-TX was surprised and disappointed that the DISD made the decision to send all the fifth-grade boys to see *Red Tails*, leaving the girls behind.

For too many years in Texas and elsewhere in the nation, girls have been left behind in schools, playing fields and workplaces, resulting in the imbalance in pay equity (women still get only about \$.78 for every \$1.00 men earn). Women and men must be able to compete on equal footing in sports, academia, and the workplace. Our schools have an obligation, enforceable through Title IX, not only to treat girls and boys equally, but also to avoid the appearance of inequitable treatment.

For any school district to make so blatantly discriminatory a decision tells us that we still have a very long way to go in Texas in sensitizing school boards and administrators to this issue. We think it is very likely that no one at DISD meant to make a gender-biased decision; it was a thoughtless mistake that should give all of us an excellent "teachable moment". It is only through discussion and then positive action that our girls will be confident that they can expect equal treatment. We expect that already; all Texas school districts have non-discriminatory policies in place. The question is, are these policies fully internalized? Do the administrators fully believe that these policies are important and should be considered in making campus decisions? And do they know that their bosses, the School Board members, are truly committed to these policies? All Texas school districts would do well to examine their policies and the implementation of these policies to ensure that such a mistake does not occur again.

In 1987, Congress passed a resolution designating March as Women's History Month. International Women's Day is celebrated on March 8.

The National Women's

<u>History Project</u> identifies the 2012 theme as "Women's Education— Women's Empowerment."

In discussing the theme, NWHP con-

cludes: "The equal opportunity to learn, taken for granted by most young women today, owes much to Title IX of the Education Codes of the Higher Education Act Amendments. This legislation, passed in 1972 and enacted in 1977, prohibited gender discrimination by federally funded institutions. It has become the primary tool for

women's fuller participation in all aspects of education from scholarships, to facilities, to classes formerly closed to women. Indeed, it transformed the educational landscape of the United States within the span of a generation."

As women, we must all stay vigilant to safeguard these gains. Women's Education Women's Empowerment

AAUW Stands Up for Women's Health

Thanks to the immense pressure exerted by AAUW, certain senators, and millions of Americans, the Susan G. Komen for the Cure Foundation backed down from its decision to cut grants to Planned Parenthood. This is a victory in the fight to take politics out of women's health. AAUW is now also a key player in the fight to ensure that all women have access to contraception without a co-pay, no matter where they work or learn. Note: **Texas Health and Human Services Com**missioner Tom Suehs

signed a rule Feb. 23 defunding Planned Parenthood in Texas, and clinics that provide health care for lowincome Texas women, including contraceptives and cancer screenings, will likely cease operation in March, according to the *Dallas Morning News* (February 24, 2012, pp. 1, 4A).

Victory for Legal Advocacy Fund Case AAUW is celebrating another Title IX case victory. The LAF-supported case Parker v. Franklin County Community School Corporation centers on the scheduling of



girls' high school basketball games in non-prime time slots. The U.S. District Court for Southern Indiana dismissed the case, but the U.S. Court of Appeals for the 7th Circuit overturned that dismissal in January. The case is remanded for further consideration, and LAF will be right there with the plaintiffs.

AAUW Members Heading to the United Nations This month, we will be joining women from around the world for the 56th U.N. Commission on the Status of Women, held February 27–March 9 in New York at U.N. headquarters. AAUW's U.N. representative, Carolyn Donovan, is looking forward to welcoming members from around the country, who will attend forums, workshops, panels, and a variety of events focused on the empowerment of rural women.
