The speaker for the evening is Dr. Mandy Stewart, Assistant Professor of Bilingual and English as a Second Language Education at TWU. Dr. Stewart began her career working with elementary and middle school English learners in the Fort Worth ISD. She later taught adult English as a Second Language and Spanish classes. Just prior to joining the TWU faculty, she taught teacher education courses at the University of North Texas, where she won the university's Most Outstanding Teaching Fellow award in 2010. In 2013, she was named a PDK Emerging Leader for her research in this field.

Dr. Stewart's research interests include leveraging the out-of-school literacies of adolescent English learners to promote academic success. She is also interested in multilingual and multicultural literature that honors students' cultural and language backgrounds. The title of her presentation is *Disseminating Our Research and Knowledge to Impact Policy, Practice and Public Opinion*.

**Tamiel Turley** is a Senior at the Texas Woman's University. She is majoring in Biology and expects to graduate in December 2015. She began college at Austin Community College and finished there with a 4.0 grade point average and has maintained this same level of achievement since transferring to TWU in 2012. She joined Dr. Sarah McIntire's research team that does laboratory studies on plasmid DNA of the bacterium Helicobacter pylori and will continue on this research work until graduation. She has recently received the Chancellor's Student Research Scholar Award. She volunteered last spring with Denton AAUW's Expanding Your Horizons conference at TWU. She is a member of the Phi Kappa Pi Honor Society, member of the National Collegiate Scholars, the Beta Beta Beta Honor Society, the Alpha Lambda Honor Society, and the Phi Theta Kappa Honor Society.

**Jennifer Roland** is a Doctoral Student in Women's Studies at Texas Woman's University and expects to graduate in May 2015. She holds a Master's degree in Social Work from Indiana University. 2014/2015 will be Jennifer's Dissertation Research Year. She is exploring creative ways to deal with the many gaps in social work practice by bringing feminist/womanist methods to social work. She wants to create a holistic framework to be used to engage women in social work practice. Her goal is to work in the academy training new social work professionals as well as in the community working with vulnerable women. She works at TWU as a Graduate Teaching Assistant, teaching undergraduate students. Jennifer has presented a paper at the National Women's Studies Association.

**Thao Huynh** is a Senior at the University of North Texas. She has a double major in Violin Performance and Biology and expects to graduate in May 2015. While the two majors seem unusual, Ms. Huynh strongly believes that "interdisciplinary studies are important for creativity and innovations in all aspects of life." Her life goals are to continue studying music and to become a marine biologist. At UNT she has earned numerous awards and recognitions, including the North Texas Achievement Scholarship, Euline and Horace Brock Merit Scholarship, Shaun Burns Memorial Scholarship, Symphony Orchestra Scholarship and she is a Dean's List, President's List, and Honor Student in the Strings Department of the College of Music.

**Lola Obamehinti** is a Doctoral Student in Information Science at the University of North Texas and expects to graduate in May 2017. She holds the Bachelor Arts degree in Journalism from Southern Methodist University and the Master of Journalism degree in Strategic Communications from University of North Texas. Her ultimate goal is to utilize communications research to impact business processes, focusing on how technological advances affect productivity in the workplace. She would like to work as a consultant or analyst within the information technology field and then transition into a university professorship. At both SMU and UNT she has received many awards, including at SMU participation in the Hilltop Scholars Program and Emerging Leaders Program and at UNT the UNT Mayborn Conference Award, Margaret Vines Benson Graduate Scholarship, and the Alpha Chi National College Honor Society.


## President's Corner

# The Era of Women



The era of women is dawning. Almost 94 years ago, women gained the right to vote with the passage of the 19th Amendment to our U.S. Constitution. This right was granted after 70 years of advocacy by women like you and me: housewives, students, educators, leaders and supporters. Back then, we banded together for to ensure our daughters and sisters would have a political voice equal to men.

Now, we must work together again.

Despite our many advances over the years, women today stand at a crossroads. Constantly under attack, women's rights continue to erode. Worse, women are still not granted full equality under the law. The U.S. Constitution expressly protects women from gender discrimination when voting and that is where our protections end. The 14th Amendment, ratified in 1868, only applies protections to: race, religion and national origin. Supreme Court Justice Antonin Scalia is on record stating that in its current state the U.S. Constitution does not provide equal protection based on gender.

On August 26, in celebration of the 19th Amendment and the voting rights it bestowed to women, we ask you to join to continue the work of our foremothers and allies by working for the passage of the Equal Rights Amendment (ERA). Contact your U.S. Representative and Senator and ask them to support equality for women by endorsing the removal of the ERA deadline. Together, we can herald a new era of woman.

# League of Women Voters and National Voter Registration Day 2014



The National Voter Registration Day is coming, and the League of Women's Voters (LWV) urges everyone to make this year's Registration Day the biggest ever. More than 1,000 nonprofits, government officials, businesses and other groups have already signed up to participate. Nancy Pelosi, Glenn Beck, Usher, Pearl Jam, the President, and thousands of other public figures have actively supported the goals of National Voter Registration Day; and the bipartisan National Association of Secretaries of State (NASS), representing chief state elections officials from every state, issued a 5-year resolution declaring the last Tuesday of September as National Voter Registration Day.

Make plans to celebrate by encouraging your social networks, email contacts, friends, and family to register to vote or update their registration if they've moved, changed their name or changed their political affiliation since the last election.

## Register to Vote

To vote in Texas, you must be registered. Simply pick up a voter registration application, fill it out, and mail it at least 30 days before the election date. Online registration is available at <http://www.sos.state.tx.us/elections/voter/regrv.shtml>.

### You are eligible to register to vote if:

- You are a United States citizen;
- You are a resident of the county where you submit the application;
- You are at least 18 years old on Election Day;
- You are not a convicted felon (you may be eligible to vote if you have completed your sentence, probation, and parole); and
- You have not been declared by a court exercising probate jurisdiction to be either totally mentally incapacitated or partially mentally incapacitated without the right to vote.

### Are you already registered?

To confirm your voter registration status, you may select one of three methods to perform a search on the registration website:

- Your Texas driver's license number, if you provided it when you applied for voter registration;
- Your Voter Unique Identifier (VUID), which appears on your voter registration certificate;
- Your first and last name.

Prior to dinner, President Shirley Lacroix welcomed everyone and reminded everyone that in lieu of the normal April meeting members and their guests are invited to attend the Apr. 10 performance of Hello Dolly at the Campus Theater at \$10/ ticket. She introduced the board who are continuing to serve for their second year and thanked past board members. Members were asked to introduce their guests.

Dr. Barbara Ashfeld (guest of Connie Martinez)

After dinner, Connie Martinez introduced the speakers, Anita Hawley and Anita Washborn. David and Sandra's presentation was entitled "Happy Healthy Heart Through Humor."

Shirley called the meeting to order at 7:50.

Laura Hanson presented the minutes of 2/5/2013. The minutes stand approved as distributed.

Treasurer Ruth Johnson presented the treasurer's report. Ruth reminded the members that it is time to start renewing memberships for next year. Ruth will have the forms in April. The treasurer's report was filed for audit.

### **Committee Reports:**

Patsy Roe (Public Policy) reminded the members that 2 resolutions have been filed to remove the deadline to pass the Equal Rights Amendment. AAUW has proposed a barrage of calls, emails, and twitter posts on Friday Mar. 7 from 12-2. A sample script is available from AAUW. Mary Saunders (Expanding Your Horizons) informed the members that approximately 170 girls attended this year, mostly 6<sup>th</sup> and 7<sup>th</sup> graders. The majority were from Denton, and 96% had never attended before. Around 99% heard about EYH from a teacher, and the girls overwhelmingly said that they had found it helpful and would come again. Connie Martinez ( Program Committee) Reminded that the April meeting will be attending Hello Dolly on Thursday, April 10 at 7:30 at the Campus theatre on Hickory. Ticket orders are due to Janice by Mar. 28. Connie also requested ideas for next year to be emailed to Connie [Martinez@UNT.edu](mailto:Martinez@UNT.edu). Elizabeth Snapp (scholarship committee) was not present, but a reminder was issued that the deadline for scholarships is Apr. 1 and so far have 5 applications, 3 from TWU and 2 from UNT.

### **Unfinished business:**

Janice reminded members that, per a suggestion at the Feb. meeting, a hat would be passed for scholarships at Hello Dolly in April.

Stephany Compton spoke about the AAUW Texas State Convention. The deadline was extended to Mar. 15. As we need to send a list of members who want to be voting delegates, please let Stephany or Shirley know by Mar. 31. Shirley reminded the members that the AAUW branch has 7 votes. Sarah McIntire suggested that Board Members be given preference on attending the State Convention.

### **New Business**

Mary Saunders reminded members that 2020 will be the centennial anniversary of women gaining the right to vote.

The meeting adjourned at 8:17.
